Re: Child Care Fee Reduction Initiative

Katies Korner Childcare has been approved to participate in the Child Care Fee Reduction Initiative (CCFRI) to reduce parent fees.

Parent fee reduction amounts that Katies Korner Childcare will receive are prescribed by the Ministry of Education and Child Care and are based on type of care. The maximum amount(s) Katies Korner Childcare will receive to reduce parent fees for full-time care, per child, are listed below (**part-time enrolments will receive a pro-rated amount**):

- \$900/month – Group infant/toddler (under 36 months) care
- \$545/month – Group child care for 3 years to kindergarten (before school entry)
- \$320/month – Group care for kindergarten children

Additionally, Katies Korner Childcare was approved by the Ministry to implement the following fee increase(s) effective April 1, 2024

- \$44.00/month – Group infant/toddler (under 36 months) care
- \$30.00/month – Group child care for 3 years to kindergarten (before school entry)
- \$14.00/month – Group care for kindergarten children

Katies Korner Approved Closure dates from April 1, 2024 to March 31, 2025:

We now have to approve all closure dates with the ministry to fulfil our contract obligations. They have allowed for up to 4 weeks per contract of closures.
